

The approval of the various institutions granted upto 1995-96 academic session is on the condition that documentary evidence for complete compliance including implementation of AICTE pay scales to teachers in the form of a sworn affidavit is submitted by the institution latest by 31.1.96 failing which the institution shall be liable for action including withdrawal of approval.
