Consideration of approval of Pharm.D course & examination.

Sir.

This has a reference to subject cited above. In this connection I am directed to state that matter regarding approval of your institution was placed in 83rd Central Council of the PCI held in May, 2009, which decided as under :-

- It was decided to grant approval for 2009-2010 academic session for 30 admissions for the conduct of Ist year Pharm.D course.
- It was further decided to instruct the institution
  - that every year it has to apply to PCI in the SIF for the conduct of early inspection for year-wise approval for conduct of course or otherwise on the basis of which the institution can make further admission/no admission. When the students are in the final year Pharm.D, an inspection will be conducted by PCI for consideration of approval u/s 12 of the Pharmacy Act for the purpose of registration as pharmacist. It is the responsibility of the institution to apply in the prescribed SIF to PCI before due date.
  - ii) to comply with the requirements of Pharm.D. Regulations, 2008 particularly regarding appointment of teaching staff, equipments and Hospital facility.

For guidelines regarding "SIF submission last date" and "Affiliation fee", kindly refer to Council's website www.pci.nic.in.

You are requested to follow the instructions of the PCI regarding submission of affiliation fee and Standard Inspection Form (SIF) within the stipulated time period as fixed by the PCI.
